

\$200 Digital Visa Gift Card Donation Challenge - Terms and Conditions

1. Promoter

The promoter is **Variety - the Children's Charity Victoria**, ABN 80 145 257 414, H71, 63-85 Turner Street, Port Melbourne VIC 3207 ("Variety" or the "Promoter").

2. Promotion

The **\$200 Digital Visa Gift Card Donation Challenge** ("Promotion") is a fundraising incentive for registered United Energy Around the Bay 2026 participants fundraising for Variety. The Promotion is intended to encourage participants to seek support for their Variety fundraising page in the lead-up to United Energy Around the Bay 2026.

3. Promotion period

The Promotion opens at **8am AEDT on 5 October 2026** and closes at **8am AEDT on 6 October 2026** ("Promotion Period").

Donations received outside the Promotion Period will not qualify for entry.

4. Eligibility

Entry is open to individuals who:

- are registered to participate in United Energy Around the Bay 2026;
- have an active fundraising page supporting Variety - the Children's Charity Victoria;
- are aged 18 years or over; and
- receive at least one Eligible Donation during the Promotion Period.

Employees, directors and contractors of Variety who are directly involved in administering the Promotion, and their immediate families, are not eligible to enter.

5. How to enter

To enter the Promotion, an eligible participant must receive at least **one Eligible Donation** to their official Variety fundraising page during the Promotion Period.

An "Eligible Donation" is a donation of any amount that:

- is made online through the participant's official Variety fundraising page;
- is successfully processed during the Promotion Period;
- is made by another person and not by the participant to their own fundraising page; and
- has not been cancelled, refunded, reversed or charged back before the draw.

Offline donations, cash donations or donations that cannot be verified through Variety's fundraising platform are not eligible for this Promotion.

6. Number of entries

Each eligible participant will receive **one entry into the draw**, regardless of the number or value of Eligible Donations they receive during the Promotion Period.

Receiving more than one donation does not provide additional entries.

7. Prize

There is one prize.

The prize is **one \$200 AUD Digital Visa Gift Card**, with a total prize value of \$200 AUD.

The prize is subject to the gift card provider's applicable terms and conditions, including any expiry date, activation requirements and restrictions on where prepaid Visa cards may be used. Any purchase or activation fee associated with issuing the prize will be paid by Variety and will not reduce the advertised \$200 prize value.

The prize is not transferable or exchangeable and cannot be redeemed through Variety for cash or another prize.

Visa and the supplier or issuer of the Digital Visa Gift Card are not sponsors of, and are not otherwise associated with, this Promotion.

8. Prize draw

The prize draw will take place at **11.00am AEDT on 6 October 2026** at Variety - the Children's Charity Victoria, H71, 63-85 Turner Street, Port Melbourne VIC 3207.

Variety will identify all eligible participants from its fundraising records following the close of the Promotion Period.

One winner will then be selected at random from all eligible entries.

Each eligible entry will have an equal chance of being selected.

Participants do not need to be present at the draw.

9. Winner notification

The winner will be notified in writing by email within **two business days of the draw**, using the contact details held by Variety.

The winner may be asked to confirm their contact details before the prize is issued.

10. Prize delivery

The prize will be delivered electronically to the winner's confirmed email address or mobile number.

The winner may be required to follow the Digital Visa Gift Card provider's activation instructions to access and use the prize.

Variety will arrange delivery of the prize as soon as reasonably practicable and within 28 days of the draw.

11. If the winner cannot be contacted

Variety will make reasonable attempts to contact the winner.

If Variety is unable to identify or contact the winner, or the winner is otherwise determined to be ineligible, Variety may conduct a further random draw from the remaining eligible entries.

Any redraw will be conducted using the same random selection process as the original draw.

12. Verification and disqualification

Variety reserves the right to verify the validity of entries and donations.

Variety may disqualify an entry where it reasonably believes that an entrant has:

- provided false or misleading information;
- manipulated or attempted to manipulate the Promotion;
- arranged a donation solely for the purpose of artificially obtaining an entry and subsequently reversing that donation; or
- otherwise breached these Terms and Conditions.

13. Changes outside Variety's control

If the advertised prize becomes unavailable for reasons outside Variety's reasonable control, Variety may substitute a prize of equal or greater value where permitted by law and, where

required, with the winner's agreement.

Variety may also modify, suspend or cancel the Promotion where circumstances outside its reasonable control prevent it from being conducted as intended, subject to applicable law.

14. Privacy

Variety will use participants' personal information to administer the Promotion, determine eligibility, conduct the draw and communicate with the winner.

The winner's name and relevant contact details may be provided to the gift card supplier solely to issue and deliver the prize.

Personal information will otherwise be handled in accordance with Variety Victoria's Privacy Policy.

15. General

By participating in the Promotion, entrants agree to these Terms and Conditions.

The Promoter's decision in relation to the administration of the Promotion is final, subject to applicable law.

The Promotion is governed by the laws applicable in Victoria, Australia.
